## "Crane Innovation of the Year Award"

#### **Goal of Award**

The award is recognition of the innovation which best fulfills the Mission statement of the Cranes Technology Committee (CTC): "...to promote new technologies and communicate more efficient operational and maintenance practices for the continuous improvement of heavy industrial cranes."

#### **Subject Eligibility**

There is no intent to limit the award in any way except it should be crane or crane related, It can be a specific practice, a system of continuous improvement, a reliability enhancement; a new product, a technologically advanced product, a novel approach to solving a common problem, a method to reduce crane downtime, or a safety issue improvement. It can be a very simple subject or a complex one.

#### Nomination for the Award

Eligibility is automatically granted to those presenting at any of the AISTech Crane sessions and the Annual Crane Symposium. Other AIST conferences subject presentations during the year may be eligible if brought to the CTC's attention. For a nomination other than above a written nomination must be addressed to the Cranes Technology Committee for review at a regular meeting. It should include a full description of the merits based upon the awards selection criteria.

#### Selection of Award Winner (2 steps)

1). The selection of the three finalists of the "Crane Innovation of the Year Award" will be the sum of the measured criteria of new technology merit content (20 points), potential industry-wide applicability (10 points), and potential benefit to users of cranes (10 points). The accompanying written text and oral presentation should be clear, concise, complete, and correct but no weight is assigned for this component. The written text describing the innovation is a necessary part of being selected for this award.

2). At the first meeting after the symposium, using the symposium rating sheets as a starting point, three members will be volunteered to each act as a champion to speak individually on behalf of each of the three finalists. The champion should have a thorough knowledge of the represented subject he champions.

Final selection will be by the voting membership of the Cranes Technology Committee through a secret balloted system at the second meeting after the symposium. This vote will be strongly emphasizing the fulfillment of the CTC mission. The committee's decision is final.

### The Award

An appropriate framed plaque will be developed. It will be common to other AIST awards with the AIST logo, the award name, year, and winner. The two runner-ups will also receive plaques noting their innovation efforts.

#### **Award Presentation Ceremony**

The award presentation ceremony will be decided based on discussion with the winner. Several options are to be considered. Perhaps the award could be presented soon after decided at a dinner meeting of the winner's AIST chapter. This would get the award out soon and give recognition in the winner's residence area. And, also perhaps the award should be presented at the following year's Crane Symposium. This would be in front of the crane user group who help decide the winner. Doing both would contribute to the mission of the committee.

### Antitrust Compliance

Antitrust law prohibits agreements or understandings between two or more individuals or businesses to regulate prices or quantities of goods and services, to allocate customers or territories, to hinder or limit a competitor or potential competitor's operations, or otherwise unreasonably restrain business activity. Discriminatory pricing or servicing is also prohibited.

Every individual who participates in AIST meetings and activities should follow these guidelines:

- DON'T discuss with other members your own or competitors' prices, pricing procedures, or anything that might affect prices such as costs, discounts, terms of sale, or profit margins, or anticipated wage rates.
- DON'T make announcements or statements about your own prices or those of competitors.
- DON'T talk about what individual companies plan to do in particular markets or with particular customers.
- DON'T disclose to others any competitively sensitive information.
- DON'T propose or agree to any action intended to disadvantage or injure another company.
- DON'T stay at a meeting or activity where any such anti-competitive talk occurs.
- DO have an AIST staff person present at any meetings and insist on the agenda being followed and minutes kept.
- DO confer with AIST staff before making any statement with competitive ramifications.

It is incumbent upon all AIST members to adhere to these guidelines to avoid putting all parties and their respective companies at risk for antitrust law violation.

### Anti-Harassment Policy

The Association for Iron and Steel Technology (AIST) is dedicated to providing harassment-free events for everyone, regardless of age, race, religion, disability, gender, gender identity or sexual orientation. We do not tolerate harassment in any form of anyone attending an AIST event.

Harassing behaviors include: offensive verbal comments related to age, race, religion, disability, gender, gender identity or sexual orientation; the use or display of sexual images, activities or commentary in public spaces; deliberate intimidation; stalking or following; harassing photography or recording; sustained disruption of events; or inappropriate physical contact.
